

DANTE VALVE COMPANY'S LIMITED WARRANTY POLICY FOR CUSTOM-BUILT VALVES (AKA DANCO VALVES)

PLEASE READ THIS WARRANTY POLICY CAREFULLY. IT CONTAINS VERY IMPORTANT INFORMATION REGARDING YOUR WARRANTY-RELATED RIGHTS, OBLIGATIONS, CONDITIONS, LIMITATIONS, AND EXCLUSIONS THAT APPLY TO DANTE VALVE COMPANY'S CUSTOM-BUILT VALVES ("DANCO VALVE" OR "DANCO VALVES").

BY PLACING AN ORDER FROM DANTE VALVE COMPANY ("DVC," "US," "WE," OR "OURS") FOR DANCO VALVES, YOU ACCEPT AND ARE BOUND BY THIS LIMITED WARRANTY POLICY IN ITS ENTIRETY. DO NOT PLACE AN ORDER FOR A DANCO VALVE IF YOU DO NOT AGREE TO THESE TERMS.

1. LIMITED WARRANTY

Subject to Section 2 below, DVC warrants to the original purchaser of a Danco Valve that for a period of two (2) years from the date of shipment ("Warranty Period") that the Danco Valve and all components and parts will be free from significant defects in material and workmanship and will substantially conform to the design specifications that you provide us and that we, at your direction, instruction, or insistence, use, adopt, or incorporate into your Danco Valve ("Limited Warranty").

2. WARRANTY EXCLUSIONS

The Limited Warranty specified above does not cover:

• Valve malfunctions, failures, or non-conformities attributable to, arising from, or related to any design specifications that you provide us.

• Component and part malfunctions, failures, or non-conformities attributable to, arising from, or related to any design specifications that you provide us.

• Defects in material and/or workmanship attributable to, arising from, or related to any design specifications that you provide us.

• Valves that have been subjected to abuse, misuse, neglect, negligence, accident, improper installation, improper testing, improper storage, improper handling, abnormal physical stress, abnormal environmental conditions, or any conditions or use contrary to our instructions.

• Valves that have been reconstructed, repaired, or altered by persons other than DVC.

- Normal wear and tear.
- Scratches, dents, and cosmetic damage.

• Damages of any kind attributable to, arising from, or related to the use of your custom-build valve and/or design specifications.

WE DO NOT WARRANT THAT YOUR DANCO VALVE CAN OR WILL BE COMPATIBLE WITH ANY SYSTEM, PRODUCT, COMPONENT, AND THE LIKE. TO THE EXTENT SUCH WARRANTIES CANNOT BE DISCLAIMED, THEN SUCH WARRANTIES ARE LIMITED TO THE DURATION OF THE LIMITED WARRANTY SET FORTH IN SECTION 1 ABOVE.

In the event a Danco Valve manifests a covered defect in materials or workmanship during the Warranty Period, we will, in our sole and exclusive discretion (1) repair the valve at no charge; (2) exchange the valve with a functionally equivalent product; or (3) credit or refund your purchase price. **THESE REMEDIES SHALL BE YOUR SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF THE LIMITED WARRANTY SET FORTH ABOVE.**
