

DANTE VALVE COMPANY'S LIMITED REPAIR AND VALVE ASSEMBLY WARRANTY POLICY

PLEASE READ THIS WARRANTY POLICY CAREFULLY. IT CONTAINS VERY IMPORTANT INFORMATION REGARDING DANTE VALVE COMPANY'S "DVC," "US," "WE," OR "OURS") LIMITED REPAIR WARRANTY AND OUR LIMITED VALVE ASSEMBLY WARRANTY. THIS DOCUMENT DETAILS IMPORTANT INFORMATION ABOUT YOUR RIGHTS, OBLIGATIONS, CONDITIONS, LIMITATIONS, AND EXCLUSIONS.

BY PLACING A REPAIR AND/OR VALVE ASSEMBLY ORDER FROM US, YOU ACCEPT AND ARE BOUND BY THIS LIMITED REPAIR AND VALVE ASSEMBLY WARRANTY POLICY IN ITS ENTIRETY. DO NOT PLACE A REPAIR AND/OR VALVE ASSEMBLY ORDER IF YOU DO NOT AGREE TO THESE TERMS.

1. LIMITED REPAIR WARRANTY

Subject to Section 3 below, DVC warrants that each product repaired by DVC will be free from defects in repair workmanship for a period of two (2) years ("Warranty Period") from the date of shipment of the repaired products ("Repair Warranty")

DVC MAY REPAIR PRODUCTS NOT MANUFACTURED BY DVC ("THIRD-PARTY PRODUCTS"). SOME MANUFACTURERS' WARRANTIES MAY BECOME VOID IF ANYONE OTHER THAN THE MANUFACTURER WORKS ON SUCH PRODUCTS. IT IS YOUR RESPONSIBILITY TO ENSURE THAT DVC'S PERFORMANCE OF REPAIR WARRANTY SERVICES WILL NOT AFFECT SUCH WARRANTIES OR, IF IT DOES, THAT THE EFFECT WILL BE ACCEPTABLE TO YOU. DVC SHALL NOT HAVE ANY RESPONSIBILITY OR LIABILITY FOR THIRD PARTY WARRANTIES OR FOR ANY EFFECT THAT OUR SERVICES AND/OR REPAIR WARRANTY MAY HAVE ON THOSE WARRANTIES.

DVC'S REPAIR WARRANTY SHALL NOT, AND IS NOT INTENDED TO, IN ANY WAY ENLARGE THE SCOPE OF A MANUFACTURER'S WARRANTIES FOR ANY THIRD-PARTY PRODUCT THAT DVC SERVICES. IN ADDITION, DVC DOES NOT WARRANT PRODUCTS THAT IT DISTRIBUTES THAT ARE MANUFACTURED BY THIRD PARTIES. NO WARRANTIES EITHER EXPRESSED OR IMPLIED ARE MADE TO SUCH PRODUCTS. YOUR RECOURSE, IF ANY, SHALL BE SOLELY AGAINST THE MANUFACTURER OF SUCH PRODUCTS.

2. LIMITED VALVE ASSEMBLY WARRANTY

DVC is an authorized valve assembler for Emerson Automation Solutions ("Emerson") and for Kunkle relief valves. Subject to Section 3 below, DVC warrants that it will assemble Emerson and Kunkle valves in accordance with the manufacture's specifications and in a professional and commercially reasonable manner ("Valve Assembly Warranty"). THIS WARRANTY DOES NOT APPLY TO THE ASSEMBLY OF ANY OTHER VALVES, AND ANY AND ALL ASSEMBLY WARRANTIES ARE EXPRESSLY DISCLAIMED. IN NO EVENT DOES DVC'S VALVE ASSEMBLY WARRANTY EXTEND, OR SHALL BE CONSTRUED TO EXTEND, ANY WARRANTY OFFERED BY EMERSON AND/OR KUNKLE FOR AN EMERSON AND/OR KUNKLE VALVE THAT WE ASSEMBLE.

- Product malfunctions, failures, or defects attributable to, arising from, or related to any repair instructions or design specifications supplied by you and/or a third-party to DVC.
- Product malfunctions, failures, or defects attributable to, arising from, or related to the design or materials, parts, or components of any item that we did not manufacture.
- Defects in assembly attributable to, arising from, or related to a manufacture's specifications and/or instructions you supply us.
- Assembly nonconformities attributable to, arising from, or related to a manufacture's specifications and/or instructions you supply us.
- Damages of any kind attribute to, arising from, or related to the use of your repaired or assembled product, repair or assembly instructions, and/or design specifications.
- Any products that have been subjected to abuse, misuse, neglect, negligence, accident, improper installation, improper testing, improper storage, improper handling, abnormal physical stress, abnormal environmental conditions, or any conditions or use contrary to applicable instructions.
 - Normal wear and tear.
 - Scratches, dents, and cosmetic damage.
 - Services for which we have not received full payment for.

4. REPAIR REPLACEMENT PARTS

DVC may not be affiliated with the original manufacturer of a product brought in for repair. As such, DVC may not have access to original manufacturer parts. DVC may retain any replaced part or component and such part or component will become DVC's property. The replacement part will be yours.

In the event of a breach of the Repair Warranty or Valve Assembly Warranty, we will, in our sole and exclusive discretion (1) re-perform service at no charge or (2) credit or refund the cost of service provided. THESE REMEDIES SHALL BE YOUR SOLE AND EXCLUSIVE REMEDY FOR ANY BREACH OF THE WARRANTIES SET FORTH ABOVE.
